Secretary's Report – Motion made by Angie DeVos to approve the secretary's report. Aimee Ascheman seconded the motion. Motion carried.

Treasurer's Report

<u>Bills</u> – Bills for the month of February were presented by Cory Myhre. Total General Fund bills are estimated at \$7,763.80.
 Motion made by Deb Belaen to approve the Treasurer's Report. Cory Myhre seconded the motion. Motion carried.

Board of Trustees Report

- <u>Bills</u>: Some additional bills for this month include a bill from 1514 Media for devotionals, our annual bulk mailing permit, and a bill for snow removal from Tolk Graveling. The invoice from AgPlus for the furnaces (\$10,367.43) will be paid from the Cornerstone Fund as there is not enough money in the building fund, and this invoice needs to be paid. As any money that is borrowed from the Cornerstone Fund needs to be paid back, we will do a Walk Around offering in April, and the Endowment Fund will do a 1 to 1 match up to \$5,000 to help cover this cost.
- Organist / Pianist Salary: Aimee contacted several churches in the area about what they pay their organist / pianists. Some are volunteers so they are not paid, and the others ranged from \$38 to \$75 per service. Based on the amount we budgeted, we agreed to increase the salaries to \$60 per service, and make it retroactive to the beginning of the year.
- <u>Installation of Council</u>: As we forgot to discuss this at February's meeting, it was agreed that the council will be installed on Sunday, March 17th. This will be the next time that Tim Velde will be here.
- Motion made by Barb Knutson to approve the Board of Trustees' report. Deb Belaen seconded the motion. Motion carried.

- <u>Confirmation:</u> Angie would like to do a panel discussion with the Confirmation students on April 3rd and is looking for volunteers to be on this panel for a Q&A session. It was also suggested that maybe some members of the Altar Guild, HLCW, Endowment Committee, Choir, Scholarship Committee, etc would be interested in providing some insight into what those committees do. Terri and Deb volunteered as members of the council. Due to family commitments, Angie won't be able to teach confirmation next year.
- <u>Mission Trip</u>: The Tastefully Simple fundraiser yielded \$133. We are still waiting to hear back on how much we earned through the Varsity Pub fundraiser. We currently have 67 students signed up for the mission trip. Any students going into 8th 12th grades the fall of 2023 are eligible to go on the Mission Trip. - <u>GLOW / YOH:</u> We have 5 Wednesdays until summer break. There is a date change for 1st Communion for the 5th graders; this will now be **April 14th** due to Tim's availability. There are 10 students for First Communion. Baccalaureate is May 5th. Letters will be sent out the 1st week of April to the seniors to RSVP by April 24th, so we can have an accurate count for the senior breakfast.

- <u>VBS</u>: The deposit has been sent in for VBS which will be July 29th through August 1st. Aimee will continue to be the contact person for Hope Lutheran regarding VBS, and she is working on finding a place for the counselors to stay. He is taking classes to get his Master of Divinity degree currently. We have reached out to the scholarship committee to see if there was an option to use money from that to help with the class costs.

- Spring Clean-up day at the cemetery is Saturday, April 13th at 9am. Bad weather date is the following Saturday, April 20th at the same time. We will be picking up branches, trimming trees, and filling low spots.
- The lawnmower at the cemetery is 5 years old and is being replaced this year. Anyone with interest in buying the old mower should attend the March equipment sale at Regnier's Auction House in Canby, 9am on 3/23. The old mower is being sold on auction with a \$2500 reserve. The cemetery committee feels we can get more on an outright sale than was offered on trade-in. In the event that no bids are received in excess of the reserve, the old mower will be traded in towards the purchase of the replacement.
